HOW TO GET A CARD



The following people are eligible for a free card:

- Ocean County residents
- Ocean County or municipal employees
- Ocean County business owners
- Ocean County teachers and librarians with proof of current employment
- Ocean County students

To get your card:

- Bring current identification and proof of Ocean County residency to any branch.
- Acceptable forms of ID/proof of Ocean County residency include but are not limited to:
 - NJ driver's license
 - NJ non-driver's identification card
 - Mexican Consulate Identification card
 - Utility bill
 - FAA Pilot license
 - Current rent receipt, tax bill, mortgage statement or lease agreement
 - School ID
- The signature of a parent or guardian is required for the issuance of a library card to minor children under the age of 17 years.
- Burlington or Monmouth county residents must bring their county library card and proof of address to activate reciprocal borrowing privileges.

Out of County customers with proof of address may purchase a temporary card for \$9.00 per month.

RULES OF CONDUCT

To provide you with a comfortable and safe environment, the following behaviors are not allowed in the Library:

- Excessive noise
- Smoking
- Running
- Solicitation
- Intoxication
- Deliberate mischief
- Damaging property
- Fighting
- Threatening or harassing staff or customers
- Possession of a weapon
- Using loud, offensively coarse, or abusive language
- Interfering with another person's use of the Library
- Bringing an unauthorized animal into the Library
- Using the internet for illegal activities

LOAN PERIODS

- 21 days*:** Books, children's magazines, spoken word, music, non-fiction films, and Interlibrary Loan Materials
- 14 days:** Adult/Teen magazines
- 7 days:** Video games
- 3 days:** All feature films

***Items in high demand may have their loan period reduced from 21 days to 14 days.**

- Checkout limit:** 30 items per card
- Request limit:** 20 items per card

The Ocean County Library is not responsible for any damage to your equipment resulting from the use of its materials.

RENEWALS

All items EXCEPT browser copies and magazines may be renewed twice if not requested by another borrower. Interlibrary Loan materials may be renewed once for 7 additional days. Renewal must be done on or before the ILL's due date.

FINES & FEES

OVERDUES (PER DAY)

- \$.15** Books, magazines, spoken word, playaway, music cassettes, CDs, and all videos and DVDs with the exception of adult feature films and video games,
- \$.50** Adult feature films, and video games
- \$.50** Interlibrary Loan Materials

MISCELLANEOUS CHARGES

- \$ 5.00** Interlibrary Loan Materials requested and not picked up
- \$ 5.00** Mailing the monthly event brochure to your home (per year)
- \$ 5.00** Lost magazines
- \$ 10.00** Collection agency fees
- \$ 10.00** Returned check fees
- \$ 15.00** Maximum fines per item
- \$.20** Computer printouts
- \$.10** Photocopies/Microfilm prints

LOST/DAMAGED ITEMS

Replacement cost will be the price of the item for all materials except magazines. Customers are not eligible for refunds for lost materials that have been paid for. **"New replacement copies"** for lost/damaged print materials will be accepted if the ISBN is identical.

Please note: Cardholders and/or Parent or Legal Guardian of minor children under the age of 17 are responsible for all items on their library card & any fees/fines. Borrowing privileges are suspended when unpaid fines and fees and/or the value of overdue, unreturned material exceeds \$25.00. Please report a lost card immediately.

*** Fine and fee amounts are subject to change annually**

ESPECIALLY FOR PARENTS

The Library affirms the right and responsibility of parents and legal guardians to determine and monitor their own children's use of Library materials and resources. Parents and legal guardians for people under 17 years of age assume responsibility for their children's computer and internet use by signing their child's Library card application. To assist parents in their responsibility for their children's use of the internet, the Library:

- Provides specially designed Web pages for children and young adults, with links to age-appropriate internet sites.
- Provides commercial filtering software on all computers. This filtering software will block many specific sites, but may not block all materials offensive to all users.
- Considers the placement of public computers in each Library location to minimize inadvertent viewing of public computer sessions.
- Offers internet training classes at all locations for parents, teens and children.

Parents should inform their children of websites they do not want them to visit and may wish to supervise their children's Internet sessions.

UNATTENDED CHILDREN

The Library is a public place and the safety of all children is therefore a serious concern.

- Children under the age of 6 may not be left unattended in any part of the library.
- Children 6-8 years old must have a parent or adult caregiver in the building at all times.
- Children 9-12 years old are welcome to use the Library unattended, but should not be left alone for extended periods of time.
- When unattended children under the age of 14 are present at closing time, staff will call the caregiver.
- If a child has not been picked up within 15 minutes after closing, staff will call the local police or county security.
