September Programs include the Water/Ways exhibit at the Toms River Branch that will be on display until September 29, with supporting programs throughout the system and is located in the atrium. Water/Ways is part of the Museum on Main Street, a collaboration between the Smithsonian Institution Travelling Exhibition Service, the New Jersey Council for the Humanities, and the Ocean County Library.

Alice Hoffman, New York Times bestselling author of more than 30 works of fiction, will be the 2019 James J. Mancini program featured author on Saturday, September 14, at 6:00 p.m. at the Toms River Branch. Hoffman's latest book is titled, "The World That We Knew" will be released on September 24. The book takes place in Berlin, Germany in 1941 where Hanni Kohn decides to send her 12-year old daughter away to save her from the Nazi regime. The Library welcomes retired Fire Department of New York Lieutenant Joe Torrillo who will present his program, "Buried Alive with the Will to Survive" in Mancini Hall at the Toms River Branch at 6:30 p.m. on Thursday, September 12.
