8. Director's Report

Ms. Quinn reported on the following:

Chris Casatelli will be retiring after twenty-five (25) years of service to the Library.

Approving the 2021 Budget: Mr. Mancini, Mr. Mullins, and Ms. Quinn met with the County to review the budget. The dedicated tax will remain flat from the previous year. Mr. Mancini thanked everyone that worked on the budget stating that it is a solid budget.

2020-2021 Strategic Plan: The plan was reviewed by the Library Commission Finance Committee. Mr. Mancini reviewed the plan and would motion that it be approved.

2021 Position Control Document: The 2021 Position Control document is listed as item "I" under New Business to be approved.

National Day of Racial Healing: Today is the National Day of Racial Healing. The Ocean County Library's public services and training department invite our public and staff to join with the American Library Association and organizations across the county in honoring and recognizing the National Day of Racial Healing (NDORH). NDORH is part of the W.K. Kellogg Foundation's Truth, Racial Healing and Transformation effort.

The NDORH is an opportunity for people, organizations, and communities to call for racial healing, bring people together in their shared humanity and take action together to create a more just and equitable world.

Racial healing is a process that restores individuals and communities to wholeness, repairs the damage caused by racism, and transforms societal structures into ones that affirm the inherent value of all people. It creates systems where every person has an opportunity to thrive. Storytelling is an important part of this process. Listening to and acknowledging another person's story is part of the healing process and our shared humanity.

Ocean County Library's #1 circulating titles: The top title in both eBook and eAudio for the Overdrive Platform was Where the Crawdads Sing, by Delia Owens published by Random House. Owen's debut novel tells the story of Kya Clark. Abandoned at age 10, Kya grows up on her own and becoming self-sufficient in the wild marshes of Barkley Cove, a small town in North Carolina. Now 23, Kya is known as the "marsh girl" and has learned her life lessons from the natural world around her and which is her home. Kya becomes drawn to two young men, one of whom teaches her to read. This novel is a story about nature, a coming of age story, and a story about murder investigation and courtroom drama with Kya's fate hanging in the balance.

The top circulating book in hoopla in 2020 was **Burning Bright** by Ron Rash and published by Ecco Press. **Burning Bright** is a series of short stories that views everyday life in Appalachia and the strength of its people from the Civil War era to the present; a people who endure poverty and violence while living in the ruggedly beautiful nature of the North Carolina mountains. This title was selected by the Toms River Regional School District for the "Big Read" a grant program of the National Endowment for the Arts in partnership with Arts Midwest. The goal is to bring communities together in programming and conversation around a work of literature. The Ocean County Library and the Toms River Branch were pleased to partner with the Toms River School District in support of their grant.

The top print title was **The Guardians** by John Grisham published by Random House. Booklist Cullen Post works for the Guardian Ministries, a shoestring operation that tries to get wrongfully convicted people out of jail. At the top of Post's to-do list is a Black man, Quincy Miller, who has been in prison for 22 years after being convicted of the murder of his divorce lawyer. However, the evidence is shaky at best: the shotgun used in the crime was never found, and a flashlight with a supposed blood spatter disappeared from evidence. Further bolstering Post's case, an "expert" who testified for the prosecution about the blood spatter n the missing flashlight has since been discredited as a charlatan. Post thinks Miller may have been the fall guy for a drug-cartel hit. The murdered lawyer took minor civil cases to keep up appearances, but his primary moneymaker was the drug cartel.

Brainfuse: Has announced a new enhancement to our HelpNow service – live chess tutoring. Chess has become a very popular pastime during the pandemic and interest has exploded with "The Queen's Gambit" a Netflix show. We have always been committed to promoting learning in its many forms. We are pleased to include this fun activity that also improved analytic and strategic thinking. Our chess tutors have certifiable qualifications such as high Elo ratings (2,000+), chess coaching experience and current or previous title (e.g. expert / candidate master). Ms. Quinn thanked Ms. Gunther, Christi Aldellizzi, Collections Supervisor, and Training Coordinator Deborah Blackwell for this information.
