10. Director's Report

Ms. Quinn reported on the following:

NJ Library Construction Bond Act: The Library has received official notification from the New Jersey State Library that the Ocean County Library will receive \$4.8 million towards the construction of the new Stafford Library Branch in Manahawkin in the second and final round of funding.

Mr. Mancini thanked Ms. Quinn, Assistant Library Director Sara Siegler and staff for their work on the grant. The funding has exceeded expectations. The building of a new Stafford Branch Library has been in the works for fifteen (15) years. Mr. Mancini also thanked the New Jersey Legislature and Governor for their support of our Library System and County.

<u>Presentations at ALA and NJLA Conferences</u>: Ms. Quinn stated that the Ocean County Library was selected to present at the American Library Association (ALA) Annual Conference in Washington, DC on the Joseph H. Vicari Sensory Room in junction with the Louisville Public Library in Ohio. Ocean County Library is the first Library in New Jersey to have such a designed Sensory Space. Assistant Library Director Sara Siegler created the proposal and will present at the conference.

Ocean County Library was also selected to present at the New Jersey Library Association (NJLA) Conference in Atlantic City, NJ. Two (2) presentations will be given. The Autism Resources Committee will be presenting regarding the Annual Autism Resources Fair. Chief Librarian Kelly-Ann Pennell will be presenting on our Senior Services Homebound and Volunteer Services program along with Somerset County Library.

NJ Telehealth: Ocean County Library will be participating in the New Jersey State Library's Telehealth grant in providing iPads for use at various library locations so that the public will be able to connect with healthcare providers.

<u>Ocean County Health Department Partnership</u>: Ocean County Library will be partnering with the Ocean County Health Department by providing meeting room space for COVID-19 and flu vaccination clinics throughout 2022.

<u>Election Ballot Drop Boxes</u>: Ocean County Board of Elections has requested to place Voting Drop Boxes at the Brick Branch this is the thirteenth (13th) location to have voting drop boxes.

2022 Library Budget: The 2022 Ocean County Library Budget is currently under review with the Library Commission Finance Committee.

<u>Long Beach Island Lighting</u>: Lighting replacement is currently ongoing at the Long Beach Island Branch and will be completed shortly.
