9. Director's Report

Ms. Quinn reported on the following:

Baby Yoda Library Cards: Since the end of March 548 Baby Yoda Library Cards have been handed out. Customer feedback has been overwhelming positive. A young man visited the Lakewood Branch, walked over to the desk and said, "This is the coolest thing ever! I'll take a Baby Yoda!". A family visited the Jackson Branch because their school had told everyone about the new Baby Yoda cards. The child informed the Branch that the whole class cheered and that she wanted to be the first in her class to get one. They also made a card for her baby brother.

<u>Prom Dress Drive</u>: Ocean County Library's Prom Dress Drive is currently on-going at the Brick Branch. So far, 277 dresses have been given away. 198 at the Toms River Branch and 79 at the Little Egg Harbor Branch.

Return of Library Programs: Patrons are enjoying the return of library programs to our branches. The Brick Branch received a letter from a library patron who attended the Charlie Zahm Concert, "Salute to Broadway" sponsored by the Brick Friends of the Library. One comment was, "We are lovers of Broadway Music and this was an afternoon delight."

Stafford Branch will celebrate **First Responders Day** tomorrow, April 20, 2022. Patrons can join the library outside as they will be visited by a fire truck, an ambulance, and a police vehicle.

The Waretown Branch provided space for the Ocean Township (Waretown) Senior Services programs due to the temporary closure of their facility.

Read with Pride Adult Book Club: Ocean County Library launches the "Read with Pride Book Club" on April 28, 2022, at 7:00 p.m. at the Toms River Branch to meet the reading needs of all members of our community. Each month will be a different theme and will focus on books featuring prominent LGBTQ+ characters. The book discussion is for those who identify as LGBTQ+ or who simply want to learn more about LGBTQ+ stories and experiences. All are welcome.

<u>Chromebook & Hotspot Lending</u>: The Chromebook / Hotspot Lending Pilot Project has been successful. Since the launch in September 2021 these devices combined have circulated 685 times.

<u>Toms River Makerspace</u>: The Toms River Makerspace held its first Homeschooling STEAM Academy for teens on March 11, 2022. The most popular item was the 3D Lulzbot printer.

<u>Staff Development Day</u>: Ocean County Library's Staff Development Day will be held on Friday, May 13, 2022. This year will be a hybrid of in-person and virtual. All Library Commissioners are welcome to attend.

Courage to Remember Exhibit: The Ocean County Board of Commissioners and the Ocean County Division of Cultural & Heritage invites the Ocean County Library Commission, the Ocean County Library Foundation, and the Ocean County Library's Management Team to attend the Simon Wiesenthal Center's Courage to Remember Exhibit tomorrow, April 20, 2022, at 5:30 p.m.
