

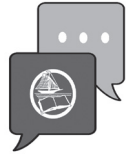

LOAN PERIODS

- 28 days:** Equipment, including but not limited to laptops, Launchpads, tablets, and WIFI hotspots. *Ocean County Residents only.*
- 21 days*:** Books, children's magazines, spoken word, music, non-fiction films, and Interlibrary loan materials
- 14 days:** Adult/Teen magazines
- 14 days:** Video games
- 7 days:** All feature films

*Items in high demand may have their loan period reduced from 21 days to 14 days.

- Checkout limit:** 60 items per card
3 video games
- Request limit:** 20 items per card
- ILL Request limit:** 5 items per card

The Ocean County Library is not responsible for any damage to your equipment resulting from the use of its materials.

RENEWALS

All items EXCEPT browser copies and magazines will be automatically renewed twice if not requested by another borrower. Interlibrary loan materials may be renewed once for 7 additional days. Renewal must be done on or before the ILL's due date.

FEES

THE OCEAN COUNTY LIBRARY IS FINE FREE

The Library will still apply due dates for the books and materials, and will continue to send reminders when the items are due back.

Patrons are given a ten-day grace period to return overdue items before borrowing privileges will be suspended or until the cost of replacement has been paid. Patron accounts may be sent to our collection agency, which includes an additional \$10.00 Service Charge.

LOST/DAMAGED ITEMS

Replacement cost will be the price of the item for all materials except magazines. Customers are not eligible for refunds for lost materials that have been paid for. "**New replacement copies**" for lost/damaged print materials will be accepted if the ISBN is identical. Refunds for lost materials paid for and then subsequently found and returned will be considered on a case by case basis by Library Administration.

Please note: Cardholders and/or Parent or Legal Guardian of minor children under the age of 17 are responsible for all items on their library card & any fees. Borrowing privileges are suspended when unpaid fees and/or the value of overdue, unreturned material exceeds \$25.00. Please report a lost card immediately.

UNATTENDED CHILDREN

The Library is a public place and the safety of all children is therefore a serious concern.

- Children under the age of 6 may not be left unattended in any part of the Library.
- Children 6-8 years old must have a parent or adult caregiver in the building at all times.
- Children 9-12 years old are welcome to use the Library unattended, but should not be left alone for extended periods of time.
- When unattended children under the age of 14 are present at closing time, staff will call the caregiver.
- If a child has not been picked up within 15 minutes after closing, staff will call the local police or county security.

RULES OF CONDUCT

The following activities are not permitted:

1. Fighting; physical or verbal threats.
2. Violent or tumultuous behavior.
3. Loud and offensively coarse or abusive language.
4. Being intoxicated or under the influence of cannabis or cannabis products. Hereafter, the word cannabis will include cannabis and cannabis products.
5. Damaging Library property.
6. Preventing or disrupting a lawful meeting.
7. Improper interfering with the use of the Library.
8. Communicating in a manner likely to cause annoyance or alarm; interfering with staff's performance of their duties.
9. Striking, kicking, shoving, or other offensive touching, or threats to do so.
10. Stealing.
11. a. Smoking or use of any drug constituting a controlled dangerous substance as defined by New Jersey law.
b. Ingestion or consumption of alcohol, tobacco, cannabis, or other controlled products as defined by New Jersey law.
12. Guide or service animals as defined in the Americans with Disabilities Act and/or the New Jersey Law against Discrimination ARE permitted in the Library when accompanying a person with disabilities. No other animals are permitted in the Library unless they are part of an authorized educational program.
13. Offensive bodily hygiene. Bathing and laundering clothes in the public restrooms are specifically not permitted.
14. Eating or drinking, except in designated areas.
15. Improper attire. Shoes, shirts, pants, shorts, or bathing suit cover-ups must be worn.
16. Soliciting, gambling or panhandling; distribution of unauthorized printed materials, petitions, or surveys.
17. Carrying or manufacturing weapons.
18. Using the Internet to display obscenity.
19. Using the Internet for
a. illegal activities or
b. child pornography.
20. Sleeping, except for young children under the supervision of a parent or caregiver.
21. Oversized or unattended bags or carts. Unattended or abandoned items may be subject to seizure or removal from the Library.
22. Unauthorized filming of any nature, photography, or video recording, without the express written authority of the Library Administration.
23. Depositing bodily fluids on Library furnishings or property.
24. Neglecting to provide proper supervision of children by parent or caregiver.
25. Inappropriate exposure of the body; any conduct of a lewd or lascivious nature.
26. Sexual harassment of patrons or staff.
